NOTIFICATION

Effective July 1, 2025, the funds availability policy will be adjusted. The changes include increasing the next-day availability amount from \$225.00 to \$275.00. Previously, longer delays may apply if you deposited checks totaling more than \$5,525.00 on any one (1) day. This amount is increasing to \$6,725.00. Any reference of \$5,525.00 in the "Special Rules for New Accounts" section will be increasing to \$6,725.00. The funds availability policy is available on the website at www.saratogafcu.org/forms.

*Annual Percentage Yield (APY). Dividend Rate 3.93%. Dividends compound monthly. Penalty may be imposed for early withdrawal. Minimum balance to open is \$500. Share Certificate does not automatically renew and is for new money deposits only. Advertised rate and APY are offered at the credit union's discretion and may change daily. We may impose a penalty if you withdraw any of the principal before the maturity date. For 30 to 60 days Certificate accounts, the amount of the early withdrawal penalty is 30 days dividends. For all other certificate accounts, the amount of the early withdrawal penalty could reduce earnings on the account. Membership eligibility: Must live, work, worship, or attend school in Fulton, Montgomery, Saratoga, Washington or Warren County.
